SILVER SPURS FUTURITY & DERBY - RULES & REGULATIONS

- Futurity Open to any horse which is a foal of 2015 or later (5yrs & under). Horse must not have competed in any barrel race, rodeo, jackpot or other futurities before November 15 of 2019. Horse may have had exhibition runs.
- 2. Derby Open to any horse which is a foal of 2013 or later (7yrs & under).
- 3. Futurity/Derby Photocopy of the front and back of registration papers on registered horse must accompany nominations. Veterinarian affidavit of year of birth and complete description of unregistered horses must accompany nomination.
- 4. Futurity and Derby will be 2 runs and a short go. Top 12 averages will resume to short go. Champions will be declared on the average of the three runs.
- 5. Running order will be drawn for 1st go and 2nd go will be in reverse order, with late entries being put at the end both go's.
- 6. Nomination payments are due June 19, 2020. E-transfer or cheque in full amount must accompany the entry form. Late fines will be \$50 if entered between June 20 August 13, 2020.
- 7. Any NSF cheques will carry a \$35 service charge.

- 8. Substitutions will be accepted for death, illness or unsoundness. Veterinarian affidavit of proof must accompany substitutions along with a \$25 fee. Substitution of rider is allowed, and free provided office is notified prior to 1st go. Selling of spots is allowed until August 13, 2020. Office must be notified of transactions.
- 9. No refunds for any reason, unless extreme weather becomes a factor for the safety of horse and rider and the event is cancelled, at that point a refund will be issued, except for the office fee. Should the owner or rider choose to turn out because of weather while the event is still a go, does not warrant a refund.
- 10. Rerun if timer fails no penalty will be carried over.
- 11. Payout Futurity & Derby
 - a. 1st and 2nd Go 35% of total prize money
 - b. Average 40% of total prize money
 - c. 30 & under entries pays 4 monies in each go and average
 - d. 31-60 entries pays 6 monies in each go and average
 - e. 61+ entries pays 8 monies in each go and average

12. Running rules & regulations

- a. Entrants/competitors and owners will be responsible for themselves and their horses. All horses may be subject to drug test, examination to meet registration identification or examination for age at the discretion of management. Ant horse examined and found to be ineligible age, failing to meet registration description or failing to pass a drug free exam will be disqualified.
- b. Inhumane treatment of horses will not be tolerated on the grounds and will result in disqualification.
- c. Competitors must be ready when called or they will forfeit their run. Will use the three-call rule.
- d. Completion of entry form or payment of entry will indicate acceptance of all rules and regulations governing this event.
- e. Not withstanding anything to the contrary herein contained it is understood that each contestant/ owner waives all claims against the Silver Spurs Futurity and Derby, organizing body, workers, etc for any injury, loss of damage which may result in anyway from the operations of activities of the Silver Spurs Futurity & Derby event.
- 13. Western attire cuff/collar, boots, helmet/cowboy hat
